#### **Board Chair Announcement**

The following statement was read out by Board Chair George Tsiakos:

I would like to start tonight's Board of Education meeting with news as it relates specifically to the North Vancouver Board of Education and one of our trustees.

It is with regret that I must inform the Board of Education and School District staff that yesterday, February 22, 2021, Secretary Treasurer Jacqui Stewart advised me that she received a letter of resignation from Trustee and Vice Chair Devon Bruce.

Trustee Bruce was elected by District of North Vancouver electors in fall 2018 and on December 1, 2020, was acclaimed as Vice Chair. During his time serving on the Board, Trustee Bruce worked collaboratively with fellow trustees to make policy decisions that govern all aspects of education with the North Vancouver School District. Like his fellow trustees, Trustee Bruce worked tirelessly to support the School District's overarching vision and district priorities in the pursuit of the highest level of service we can provide to students and our community.

Trustee Bruce would like our community to know that he has enjoyed his time on the Board of Education tremendously. However, due to a growing portfolio of professional responsibilities in his work with North Shore ConneXions Society, he feels he cannot continue on with his role and responsibilities with the Board of Education at this time. I respect the decision, and I know fellow trustees, district staff, and our school community will join me in thanking Trustee Bruce for his service and wish him well.

I would like to take this opportunity to remind everyone of the purpose of the Board of Education and role of the school trustee. The Board's purpose with respect to the BC public education system is to enable all learners within the School District to develop their individual potential and to acquire

the knowledge, skills, and attitudes needed to contribute to a healthy society and a prosperous and sustainable economy.

As a member of the Board of Education, school trustees are accountable to the public for the collective decisions of the Board, and for the delivery and quality of educational programs and services. It is a responsibility that we do not take lightly and does require a commitment of time, over and above our personal and professional responsibilities.

Due to the resignation of an elected school trustee, a by-election will be required to fill this vacancy for the remainder of the four-year term ending in the fall of 2022. The North Vancouver School District will be informing the District of North Vancouver, who will run the municipal election process, of the resignation. — end —

Chair Tsiakos acknowledged the continued challenges related to COVID-19. February was acknowledged as Black History Month and Inclusive Education Month with Pink Shirt Day and the Provincial Eating Disorders Awareness both occurring in this month as well. Chair Tsiakos thanked everyone who took time to engage with the School District to provide feedback on the Board of Education's Strategic Plan.

Noel Deschenes, resident of North Vancouver, provided comments regarding the Temporary Transitional Support Option, asking the Board of Education to continue the option for the remainder of the school year.

Meredith Dawson and Melissa McConchie, both residents of North Vancouver, commented on the use of masks in elementary schools. Ms. Dawson and Ms. McConchie asked to strengthen the COIVD-19 safety measures in North Vancouver schools.

#### A.4. Stakeholder Comment Period

As per the motion passed on May 26, 2020, the Board of Education provided a twenty minute stakeholder comment period to allow stakeholders to speak to items on the Board of Education Agenda.

Jennifer Branston, Co-Chair of North Vancouver Parent Advisory Council, spoke regarding the Elementary Temporary Transitional Support Option, respectfully requesting that the Board of Education continue the option for the remainder of the school year.

Katrina Russell, First Vice President of North Vancouver Teachers' Association, commented on the Elementary Temporary Transitional Support Option, asking the Board of Education to consider extending the option till the end of the year. Ms. Russell also spoke regarding Block Budgets that were provided to the schools, asking the Board to reconsider these allocations. Ms. Russell also shared her concern that the Board has not yet discussed the provincial and federal COVID-19 funding at a Public Board Meeting.

# B.1. School District No. 44 (North Vancouver) Amended Annual Budget Bylaw for Fiscal Year 2020/21

Financial Services Director Kristen Watson introduced this agenda item and noted that the Board is being asked to adopt an Amended Budget Bylaw for Fiscal Year 2020/21 pursuant to Section 113 of the *School Act* which provides the authority for a Board to amend its annual budget bylaw. The Amended Budget in the amount of \$206,792,467 was updated to take into account changes in revenue and expenditures that have occurred since the adoption of the 2020/21 Preliminary Budget on June 23, 2020.

Ms. Watson provided clarification on various budget lines including salary and benefit costs, revenue and services and supplies. Ms. Watson highlighted the risks and liabilities, changes in the operating, special purpose and capital funds.

The revenue was increased by \$10,049,908 over the Preliminary Annual Budget. Significant adjustments included an increase to the Operating Grant budget by \$952,724 as a result of higher than anticipated enrolment. The School District received \$1,116,823 from the Provincial Government for the Safe Return to Class Grant, and \$6,187,532 from the Federal Government for the Safe Return to School Grant. Both grants were received to support the School District with revenue and expense impacts resulting from COVID-19. The Classroom Enhancement Fund Grant increased by \$2,001,296 to fund the provisions of restored collective agreement language. International Student Tuition fee revenue increased by \$1,403,300 as a result of higher than anticipated international student enrolment.

Total planned expenditures increased by \$4,039,489. This was largely attributed to an increase in staffing and facility maintenance expenses resulting from the implementation of COVID-19 health and safety plans, as well as additional teacher staffing to support learning and the elementary temporary transition support option. Ms. Watson noted that the Amended Budget incorporates the utilization of \$2,271,193 of the Accumulated Operating Surplus to balance the Operating Budget. In addition, \$4,350,000 has been included as a transfer to local capital reserves to support School District capital construction projects and future investments in information technology and communications. Ms. Watson answered a number of questions raised by Trustees.

#### B.2. Elementary Temporary Transition Support Option - Extension to June 2021

Assistant Superintendent Pius Ryan introduced this agenda item sharing that the 2020/21 school year began with an option for parents of elementary-aged students to consider participating in a temporary transitional programming option that, in light of COVID-19, provided a delayed return to in-person instruction. The Board extended this option on December 8, 2020, based on the expressed needs of families to spring break.

The Board of Education continued to receive feedback from families in the Elementary Temporary Transition Support Option requesting that the option be continued to the end of the 2020/21 school year. Assistant Superintendent Ryan noted that the Option would continue in the same delivery format, with the same level of supports currently provided to students as introduced in September 2020.

that the Board of Education confirm further extension of the Elementary Temporary Transition Support Option until the end of the 2020/21 school year, and that the option be provided to those families currently participating, in the same format and design as introduced in September 2020. Memorandum): Proposed 2021/22 School Calendar for Board Approval

#### Narration:

BC school districts are required by the *School Act* to individually design and establish annual school calendars for their respective districts. Specific criteria and requirements are defined by the School Calendar Regulation 314/12, including the minimum number of instructional hours to be provided to students, and the timelines and processes for the development and submission of school calendars. School districts are required to provide a minimum one-month opportunity for employees and parents of students to comment on proposed calendars prior to a Board of Education confirming a final school calendar. School calendars must be submitted to the Ministry of Education by March 31<sup>st</sup> of the year prior to the calendar implementation.

Development of school calendar proposals for the Board's consideration is tasked to the North Vancouver School District's School Calendar Committee. The Committee, supported by NVSD staff and chaired by Assistant Superintendent Chris Atkinson, is comprised of representatives from NVSD education partner groups: the North Vancouver Teachers' Association, CUPE Local 389; the North Vancouver Administrators' Association, the North Vancouver District Parent Advisory Council; the District Student Leadership Council. Additionally, committee membership includes two Board of Education Trustees.

The School Calendar Committee met twice in the fall of 2020 to finalize a proposal for the 2021/22 School Calendar. The Committee's proposed School Calendar was provided to the Board of Education, for their information, at the Public Board Meeting held January 19, 2021.

The 2021/22 Proposed School Calendar provides for:

- the first day of school to fall on September 7, 2021, the first day following Labour Day
- a two-week Winter Break from December 20, 2021 to January 3, 2022, inclusive (Monday, January 3<sup>rd</sup> is an In Lieu Statutory Holiday; schools re-open Tuesday January 4, 2022)
- a two-week Spring Break from March 14, 2022 to March 25, 2022, inclusive
- four (4) Staff Collaboration Dates on which students will attend for a shortened day
- the last day of attendance for students to be Wednesday, June 29, 2022

The School Calendar Regulation requires that proposed calendars be made available for public comment and, accordingly, a public comment period was established effective February 1, 2021. The 2021/22 Proposed School Calendar was published to the school district's Calendar webpage and notification of the public comment opportunity was sent by email to parents of students as well as to all NVSD staff. Additionally, information regarding the public comment period and the proposed calendar was shared on each of the NVSD social media channels.

Last year, the NVSD introduced the online engagement tool Thoughtexchange to gather public input regarding school calendar proposals. The public comment period closed at midnight Sunday, February 28, 2021. A total of 194 individual "thoughts" were posted to Thoughtexchange in response to the question: What are your thoughts about the proposed calendar dates for 2021/22?



The number of responses was slightly increased from last year's participation for the 2020/21 school calendar. This year, 243 individuals participated, versus 235 last year; 194 unique "thoughts" were posted this year, versus 152 last year. (*Note*: not all participants provide unique thoughts - some choose only to star/rate the comments of others). The number of participants and comments is generally consistent with those received historically.

This year, approximately 25 of the posted comments referenced the secondary school quarter system newly implemented this year in response to the COVID-19 pandemic. These comments have been shared with school district staff who are currently surveying secondary school students, families and staff for feedback on their experience of the quarter system schedule.

In addition to adding unique thoughts, the Thoughtexchange tool allows participants to rate or rank agreement with the posted comments of others. The highest "rated/ranked" statements addressed the scheduling/balancing of non-instructional dates (including connection to, or creation of, long weekends) and the 2021/22 year-end date falling mid-week (Wednesday, June 29<sup>th</sup>).

A listing of the unique comments posted is attached to this Board schedule and is accompanied by a brief summation of the most common themes and feedback. The listing was shared with members of the School Calendar Committee for their discussion at their March 4<sup>th</sup> committee meeting.

Assistant Superintendent Chris Atkinson will review the results of the public comment period and the final version of the Proposed 2021/22 School Calendar.

Should the Board approve the Proposed 2021/22 School Calendar, the calendar will be submitted to the Ministry of Education prior to the legislated March 31, 2021 submission deadline. In May, upon confirmation of the dates selected by the NVTA for non-instructional days next year, the 2021/22 calendar will be updated with the confirmed ProD dates, and will be re-published and circulated to the community as the finalized NVSD 2021/22 Approved School Calendar.

# PUBLIC COMMENT FEEDBACK PROPOSED SCHOOL CALENDAR FOR 2021/22

The Provincial School Act requires that Boards of Education establish a school calendar for each school year and, as part of that process, that the proposed calendar be made available for public comment prior to receiving final approval.

The opportunity for public comment regarding the 2021/22 Proposed School Calendar was provided this year through use of the online engagement tool Thoughtexchange. The question posed to participants was:

What are your thoughts about the proposed calendar dates for 2021/22?

As in previous School Calendar consultations, the comments received identified the same general themes, namely responses regarding:

- start and/or end dates of the calendar year
- number and scheduling of Professional Development/Non-instructional Days
- length and scheduling (date selection) of Winter and Spring break periods
- staff collaboration time/shortened days
- support for the calendar proposal as presented.

This year, with adjusted operations due to the COVID-19 pandemic, several respondents referenced the Secondary School Quarter System schedule. These comments remain included in the listing provided, but have also been forwarded, for consideration, to staff working on the survey of secondary school students and families regarding feedback on the current year (2020/21) secondary school schedule.

Repetition of statements, or indications of support for existing comments of others, were noted within "thoughts" that referenced the following:

- alignment Professional Development/Non-instructional days with long weekends
- the number of Professional Development/Non-instructional days in general
- the duration of Spring Break
- the scheduling of Spring Break in mid-March/alignment of Spring Break with Easter long weekend
- year-end timing/last day of student attendance mid-week (Wednesday, June 29, 2022)

Seventy-four (74) comments indicated support for the proposed calendar as presented.

# Collaboration Working Group

North Vancouver School District & City of North Vancouver

## Background:

In April 2020, both the City of North Vancouver (CNV) and North Vancouver School District (NVSD) approved motions with respect to formalizing the partnership and collaboration work between the two organizations.

The motions of both governing bodies celebrate the ongoing collaboration work and further creates a formalized venue for idea generation and enhanced working outcomes at both the administrative and political level. (See Appendix A for NVSD motion and Appendix B for CNV motion). This initiative is the Collaboration Working Group.

To acknowledge the collaboration working group's effort and work, NVSD and CNV will sign a memorandum of understanding approved by both governance bodies. See draft MOU in Attachment 2.

### History of Collaboration

The City of North Vancouver and the North Vancouver School District have a long history of formal and informal collaboration. Agreements dating back to the early 1940s demonstrate that both parties have worked together with shared community spirit. Agreements included items such as wartime housing, right of ways, space and infrastructure sharing and shared programming. Recently, the parties have entered into large-scale projects that have demonstrably supported the quality of life and shared history of our community. Projects include: Queen Mary Elementary and Ridgeway Elementary Heritage Restoration projects, Queen Mary Elementary/Ridgeway Elementary/Westview Elementary purpose built child care facilities (NVSD/CNV); Lonsdale Energy Corporation sub-plant located in the Education Services Centre, Cloverley Park (NVSD), Carson Graham Secondary all weather turf field (CNV), various student art projects, Mayors' Business Recovery Committee.

## Ongoing work

Today, the City of North Vancouver and North Vancouver School District have established working relationships on a variety of topics through formal committees. CNV and NVSD staff collaborate on NVSD Capital Planning, Joint Use Committees, Work Force Housing (Balance Housing Lab), CNV Integrated Traffic Management, Safe Routes to Schools as well as ad hoc work that arises. Further, both organizations have recognized the challenge of global warming and have committed to collaboratively share best practice and explore opportunities for shared initiatives.

It is the intention that the Collaboration Working Group does not replace these formal structures; rather, it will work in conjunction and in support of these long-standing initiatives. As required, the Collaboration Working Group will receive formal updates on the work being completed within these structures.

The Collaboration Working Group appreciates the continued open dialogue that has been formed between the staffs of the CNV and NVSD and encourages continued informal connection.

## Purpose

The Collaboration Working Group of North Vancouver School District (NVSD) and City of North Vancouver (CNV) is established to create opportunities to build upon its excellent working relationships to enhance our shared community goals. The Collaboration Working Group will report annually to the North Vancouver Board of Education and City of North Vancouver Council. A standing scheduled meeting will be created between the City of North Vancouver Council and the North Vancouver Board of Education in the third quarter of each year. During this meeting, the Collaboration Working Group will update the respective political bodies with a summary of the prior years' work and a workflow plan for the upcoming year.

## Objectives

Together, the governing bodies and administrative staff will work towards the following objectives:

- 1. Creation of opportunities, inclusive of outside organizations/agencies that support children, families and community;
- 2. Integration of information from Joint Use committee, NVSD Capital planning committee, and CNV Integrated Transportation committee to assist in future planning and opportunities;
- 3. Joint Advocacy (Political bodies) and Collaboration (Staff) on new school sites and new related city facilities;
- 4. Recommendations to Council and Board of Education for consideration.

## Structure

#### **MEETINGS**

The Collaboration Working Group will meet four (4) times per year (Sept, Dec, March, June).

The Chair will rotate annually between organizations. The organization that is chairing the Collaboration Working Group will provide the administrative support to organize meetings, create agenda, etc. Any individual work that arises out of the Collaboration Working Group will be supported by the respective staff of the organization required/requested to complete the work.

The Chair of the Collaboration Working Group will be the Superintendent/CEO (NVSD) and/or Chief Administrative Officer (CNV). Should the Superintendent or CAO not be available for the meeting a designate will be appointed.

For the 2020/21 (Sept – June) year, the North Vancouver School District will take leadership of the Collaboration Working Group. The Chair will be the Superintendent/CEO. If the Superintendent/CEO is unavailable the Secretary Treasurer/CFO will chair the meeting.

NVSD will provide administrative support for year 2020/21.

The Collaboration Working Group will report to governing body in the following ways:

- 1. Informal Updates through "Council Workshops, Trustee Seminars, CAO email, Superintendent email:
- 2. Joint meeting yearly Board/Council dinner in fall (October)
- 3. Formal Presentations to Board/Council as required.

#### CNV:

Chief Administrative Officer (CAO)

The Collaboration Working Group will add members of staff as needed/required depending on the Agenda and subject matter.

## Topics/Work Plan for 2021

Each year, the elected officials and staff will work together to establish shared areas to work on. For 2021, the following areas will be discussed:

- New facilities Shared Use (Cloverley, HJ, NSNH, future projects)
- Land use (work force housing/balanced housing lab)
- Federal and Provincial Grant opportunities for growth (such as Sutherland track)
- Early Learning and Childcare (convener of creating a framework for early learning and out of school care in civic and school facilities)
- Opportunities emanating from ongoing working groups
  - Shared Use (Joint use agreement, infrastructure sharing)
  - Safe Routes to School (SRTS Program and Safe Mobility Strategy)

As a result of a North Vancouver School Trustee resigning in February 2021, a by-election must be held to fill the vacancy. As outlined in the *School Act*, within 30 days after a vacancy occurs, the Board must notify the municipal council of the need for a by-election. The municipality must then appoint a chief election officer within 30 days of being notified.

The 2021 School Trustee by-election will be conducted by the District of North Vancouver, as the School Trustees' electoral area was in the District of North Vancouver. The chief election officer must set a general voting day for the by-election, which must be on a Saturday no later than 80 days after the chief election officer is appointed.

The North Vancouver School District will be responsible to cover all costs associated with the by-election. The scope of the by-election will be provided in an update by the Superintendent when this is known. In respect to a timeframe, the new School Trustee can be expected to be sworn in anywhere from three to five months following the resignation.

Superintendent Mark Pearmain will update the Board of Education on the 2021 School Trustee by-election.

#### **Land Management Update**

#### Argyle Secondary School: Replacement Update

Phase 2 is now commencing with the removal of hazardous materials and deconstruction of the existing school. We expect the old gymnasium to be demolished commencing in two weeks.

#### Handsworth Secondary School: Replacement Update

Construction activity of new school is approximately 51% (at end of January) complete overall with construction activity progressing from west to east. The west part of the structure is most advanced.

- West section of building:
  - Exterior wall finishes are being installed;
  - Exterior windows have been installed;
  - Roofing is complete;
  - Interior partitions and door frames being installed;
  - Main mechanical and electrical distribution systems are in place.
- Centre section of building:
  - Structural steel has been erected and secured:
  - Exterior wall sheathing has commenced;
  - Interior walls are being framed.
- East section of building:
  - Underground servicing and foundations have been installed;
  - Structural steel has been erected and secured;
  - · Roofing has been completed;
  - Gym concrete floor has been poured;
  - Interior and Exterior wall framing are being installed.

#### Mountainside Secondary School: Seismic Upgrade

Estimated progress to date 50%

- Block 1A (Academic Wing) final occupancy expected by the end of March
  - New Siding installation 95% complete.
- Work is currently proceeding on:
  - Building formworks for two buttresses located on far east side of the school;
  - Interior plumbing, electrical rough-ins, prepping for dry-walling work to start.
- Block 1B (Learning Services)
  - Work will commence in April.
- Block 2 (Gymnasium)
  - 2 exterior concrete walls are completed;
  - Siding completed approximately 90% complete;
  - · Civil Work has commenced:
  - Roofing will commence in April.
- Block 3 (Administrative Wing)
  - New interior footings and reinforcement of existing masonry walls nearing completion;
  - New Siding installation 20% complete.

Target completion date for the Mountainside Seismic mitigation project is fall 2021.
