### Collection, Use and Sharing of Personal Information

Schools and School Districts are authorized to collect, use, and share student personal information that is directly related to and necessary for their educational functions. For other school or education-related purposes, parental or student consent is required.

- school and School District websites, social media sites (e.g. Facebook, Twitter), online video (e.g. Vimeo), and news media, with limited or public access;
- videos, CDs, and DVDs designed for educational use only.

Please note: school and district staff cannot control news media access, photos/videos taken by the media or by others in public locations (e.g. field trips or off school grounds) or school events open to the public, such as sports events, student performances, school board meetings, etc. These are considered public events. Journalistic media (including radio, television, newspapers, and other print and online media) are sometimes permitted or invited to come to the school or to

school activities and allowed to take photos or video or conduct interviews with students, for the purposes of promoting public understanding of school programs, building public support for public education, and encouraging student achievement. If you do not want your child to be involved in such activities, please deny consent on this form and also tell your child to avoid these situations and tell your child's teachers of your wishes.
