Cove Cliff Code of Conduct

The code of conduct has been established to ensure a respectful and safe learning environment for all students, staff and visitors at Cove Cliff Elementary.

At Cove Cliff we believe in fairness, consistency, and promoting student self-awareness, self-regulation, co-operation and consideration within a purposeful learning environment. We expect all students to follow our school Code of Conduct both on and off the school grounds so that their behavior reflects favorably upon them and the school at all times. Through our Code of Conduct we are able to establish a safe, respectful and responsible environment in which there is an appropriate balance between individual and group rights.

As set out in sections 7 and 8 of the Human Rights Code the Cove Cliff Community must respect the feelings of others by:

- being courteous in words and actions to others
- Not discriminating against others based on race, colour, ancestry, place of origin, religion, marital status, family status, physical or mental disability, gender identity, sexual orientation, or age

Anti-bullying measures will ensure all students, regardless of their sex, race, religion, culture, sexual orientation and gender identity or expression, enjoy a safe, inclusive and welcoming learning environment.

Student discipline will be dealt with in a progressive, fair, and logical manner. There are rising expectations for behaviour as students become older and more mature, become more personally responsible, and progress through the grades.

Cove Cliff's Code of Conduct:

Be Kind

- Invite others to join
- Encourage and be open to the ideas of others
- Accept others as they are

Be Respectful

- Play by the rules that are agreed upon before you start
- Model appropriate behaviour
- Speak politely to others with your words, tone and body
- Be responsible for your own garbage and recycle
- Follow adult directions
- Be aware of other people who are sharing the learning environment

Be Safe

- Help others in need
- Problem solve conflicts and seek help from an adult if needed
- Use equipment appropriately
- Be aware of other people who are sharing the same place

Additional School Expectations

Dress Code

Students should be dressed appropriately for the elementary school workday. Shoes and clothing should allow students to move around the classroom and playground safely and with self-respect. Clothing should not be offensive to others by absence of coverage or appearance (slogans or pictures), or cause distraction to the learning environment.

Physical activities are an integral part of the school day. Clothing should allow students to fully and safely take part in these activities both in class and during recess and lunch.

Supervision

All students are encouraged to arrive at school shortly before the 8:45 bell in the morning and enter the classroom through their outside classroom door. Parents should be aware that there is no supervision of students on the playground prior to the start of school. In order to foster independence, parents are encouraged to say goodbye to students outside the school, and allow them to enter their classroom on their own.

Recess and Lunch Supervision

Education aides, administrators, and office support staff provide supervision of students during the recess and lunch breaks.

Students need to be dressed for the weather as it is our expectation that all students will play outside even in inclement weather. Please ensure proper footwear for all seasons of play.

Out of Bounds Areas

At Cove Cliff, we have a wonderful and unique location. We are fortunate to have our very own salmon stream, which runs through our property. To protect this habitat, we have designated this area "Out of Bounds" during regular school breaks. In an effort to keep students safe, the roadway, driveways, parking lots, creek and areas beyond fence lines are out of bounds areas.

Bicycles/Skateboards & Scooters

Once on school property between the hours of 8 am and 4 pm, bicycles, scooters and skateboards should be walked and stored appropriately.

Indoor Traffic

Children enter and exit through their external classroom doors. The front entrance is reserved for adults and students and who may be late.

Litter

All students are encouraged to bring all garbage or recyclables home or use the bins provided in and outside of the school.

Leaving School

In order for students to leave the school the following procedures must be adhered to:

During instructional Hours 8:50-12:00 & 12:55-3:00

- Parents must provide a note to the teacher outlining the details of the absence

- A call into the absence line would be very much appreciated
- Parents must sign-out their child in the sign-out book at the school office

During Lunch hour

- Must be pre-arranged (phone calls home on the day of will not be permitted)
A parent signed note including where the child will be on that day must be provided to the office
- We respectfully request that students only go home for lunch and not to the Cove
If students are planning to leave for lunch together notes are required from both families.
- -Students must present the signed parent note and sign-out in the sign-out book at the school office when leaving and sign-in when returning to the school grounds.
- students must return on time

We will not be allowing students to leave the school unless proper procedures are followed.

Parents are reminded that the school is not responsible for the safety of students once they leave the school grounds.

Chewing Gum

Students are not to chew gum at school.

Hats

Although appropriate for outside, hats are not to be worn anywhere inside the building.

Electronics

Student use of personal electronic devices on the school site is not permitted during instructional hours. At times, a teacher will give a student(s) explicit permission to use an electronic device to support instruction. During these times, the students must adhere to the NVSD Acceptable Use of Technology Agreement. Electronics that are being used during non-instructional times, or without staff permission, will be held in the office until the end of the day and parents will be contacted. Please note that the school is not responsible for items brought to school.

Valuables

Students are encouraged to leave items of personal value at home. As a reminder the school is not responsible for lost, stolen or damaged items. As there is no locked storage area for instruments, band students are encouraged to keep their instruments at home. **Student toys must stay at home.**

Volunteers

Parents and community members who are working in classrooms or volunteering in the school are reminded that they need to sign in at the office and receive a visitor's tag to wear while they are in the building, or on the school grounds. This helps with the safety and security of students. Parents are asked not to be on the playgrounds during recess and lunch breaks as this makes supervision more difficult for staff members.

Meeting with Teachers

Teachers welcome communication with parents and work hard to establish strong partnerships between home and school.
