

Dear Grade 10-12 Parents/Guardians/Students:

Provincial Assessments are scheduled to be written this year during the weeks of November 4-6, 2025, January 13-14, 2026, and April 21-22, 2026. It is a graduation requirement to complete the **Grade 10 Graduation Literacy Assessment, Grade 10 Graduation Numeracy Assessment and Grade 12 Graduation Literacy Assessment.** *Students must check Grade Teams in September to view the schedule of assessments; specific information about when students sit for the assessment, locations and times will be sent to students in Teams in September. Reminders prior to the scheduled assessment(s) will follow on Teams.* Our office staff will have a list of students scheduled to write and will complete attendance input on the scheduled assessment days.

All assessments will:

- Be in the Library classroom & Computer Lab 317.
- Students must arrive at their assigned room between at 8:15am for their session
- Phones must be off and in backpacks before entering the room.
- Students who arrive by 8:15 can begin right away.
- Students will have 3 hours to write (assessments are designed to be completed in 1.5 hours)
- Students must remain in the sitting for 1 hour
- The assessment sittings are all from 8:15am-12pm each day.
- Once finished, students head to their current morning class.

Background Information:

The BC Graduation Program requires ALL students to write the following Graduation Assessments:

- **Grade 12 Literacy Assessment - Written January 19-21, 2026**Note New Date****
- **Grade 10 Literacy Assessment** – Written January 13-14, 2026
- **Grade 10 Numeracy Assessment** – Written April 21-22, 2026

The purpose of these assessments is to measure the extent to which students are literate and numerate. Rather than assess specific course curricula, the graduation assessments measure the application of numeracy and literacy skills to realistic situations. These assessments look at a students' ability to apply their knowledge and skills. Student will analyze, reason, and communicate effectively as they examine, interpret, and solve problems. Graduation assessments also emphasize the importance of the context in which students should be able to use their skills (e.g., home, employment, society).

The following policies are associated with the Graduation Assessments:

- Students are expected to take the Grade 10 Graduation Literacy Assessment and the Grade 10 Graduation Numeracy Assessment in their Grade 10 year.
- Students are expected to take the Grade 12 Graduation Literacy Assessment in their Grade 12 year.
- Assessments are scored on a proficiency scale: 1 Emerging, 2 Developing, 3 Proficient, 4 Extending.



- Anyone scheduled to write the Numeracy Assessment needs to **bring a non-graphing calculator, a pen, dark pencil and eraser, to the assessment.**
- All the Assessments are cross-curricular and stand-alone (not tied to a specific course) assessment.
- The student's outcome for each of the Provincial Graduation Assessments will be recorded on their final transcript (BC Ministry of Education).
- Students must complete all three assessments (Literacy 10, Numeracy 10, and Literacy 12) as a graduation requirement.
