#### A. Call to Order

Chair Sacré called the meeting to order at 7:00 pm and welcomed those in attendance. The traditional territorial lands of the Squamish Nation and Tsleil Waututh Nation were acknowledged.

#### A.2. Approval of Agenda

#### A.3. Public Comment Period

#### A.5. Presentation – Apple Distinguished Program

Seycove Secondary School's Performance Learning Program (PLP) was named an Apple Distinguished Program 2016-2018, being recognized as an exemplary learning environment for innovation, leadership and education excellence. Mr. John Maschak, Development Executive from Apple Canada, presented an award to Seycove teachers Bryan Hughes and Petra Willemse from the PLP Program.

#### A.6. Student Presentation – Sutherland Secondary

Sam Nygard, student from Sutherland Secondary School shared their experience in the North Vancouver School District. They discussed the importance of programming in the School District, specifically the Choices program noting that it was beneficial to their high school years in terms of personal and scholastic progression. Trustees expressed their appreciation to Sam for sharing.

#### B.1. Election of Board Chair

Secretary Treasurer Georgia Allison reported that the Board was required by its *Policy 101:* Board of Education – Role and Function and Policy 104: Board of Education - Meetings to elect one of its members to be the Board Chair. Secretary Treasurer Allison called for nominations for the position of Chair for one year, at which time, Trustee Stratton nominated Trustee Sacré. There being no other nominations, Trustee Sacré was declared Board Chair for the term of December 7, 2016 to November 30, 2017 or until a successor has been elected.

#### **B.2.** Election of Board Vice Chair

Chair Sacré called for nominations for the position of Vice Chair of the Board for one year, at which time, Trustee Forward nominated Trustee Stanley. There being no other nominations, Trustee Stanley was declared Board Vice Chair for the term of December 7, 2016 to November 30, 2017 or until a successor has been elected.

#### **B.3.** Board/Authority Authorized Courses 2017/18

District Principal Maureen Stanger shared that boards of education must authorize each Board Authority Authorized (BAA) Course and ensure it meets the Ministry of Education's BAA Course requirements. Once the courses receive Board approval, they will be submitted to the Ministry for approval.

Ms. Stanger offered an overview of the courses:

- Technology Skills for the Visually Impaired 11

Ms. Stanger responded to Trustees' questions, clarifying that there are a variety of courses put forward, accommodating all students within the North Vancouver School District.

#### B.4. Proposed Revised Policy 302: Student Conduct

Superintendent Mark Pearmain noted that boards of education are responsible for updating policies when an amended Ministerial Order comes from the Province. *Policy 302: Student Conduct* has been updated to follow BC Human Rights Code.

The announcement requires boards of education to include explicit reference to sexual orientation and gender identity or expression in their anti-bullying policies and school codes of conduct. The Policy 412 Sub-Committee asked for feedback from parents/guardians, students and staff prior to presenting it to the Board.

#### C.1. Secondary School and Academy Fees 2017/18

Superintendent Mark Pearmain introduced this agenda item and advised that boards of education may charge fees to students and parents for goods and services provided by the Board in accordance with the School Act [s. 82]. Board *Policy 706: Board of Education – School Fees* requires that each North Vancouver school and specialty academy annually establish a schedule of fees. Fees for the 2017/18 school year are determined prior to the end of 2016 to allow fee schedules to be included in the secondary school course guidebooks that are published in January 2017.

Both the 2017/18 Secondary Schedule of School Fees and the Schedule of Specialty Academy Fees 2017/18 have been brought forward to the Board for information and Trustees are encouraged to contact Principals regarding any questions they may have in relation to the fees.

#### C.2. School Calendar 2017/18 - Update

Assistant Superintendent Chris Atkinson provided the Board with an update on the status of the School Calendar Committee's work this year and reviewed the timelines and steps required to complete and approve a school calendar for the 2017/18 school year. #### Narration:

The Board is required to elect two Trustees to the British Columbia School Trustees Association (BCSTA) Provincial Council. One Trustee is to serve as the Board's representative and one Trustee is required to serve as an alternate.

BCSTA is a non-profit, voluntary organization dedicated to assisting boards of education in their key work: improving student achievement through community engagement. The key work concept, which BCSTA introduced in 1998, explains in straightforward terms what it is that school trustees are elected to do, and how they do it. Information regarding the BCSTA Governance Structure including the role of the Provincial Council can be found on the BCSTA website: <a href="http://www.bcsta.org/whatWeDo/governance">http://www.bcsta.org/whatWeDo/governance</a>.

The <u>BC Public School Employers' Association</u> (BCPSEA) is the accredited bargaining agent for the province's 60 public boards of education, for unionized teaching and support staff in the British Columbia K-12 public education system. In July 2013, the government appointed a <u>public administrator</u> for BCPSEA as an interim measure. While the appointment of a public administrator ends the legal role of the BCPSEA board of directors, the Minister of Education has invited the school trustees, to remain in an advisory capacity to government and BCSTA as they work to redefine BCPSEA's role in the future.

In the past, the Chair has appointed a Trustee Representative to the British Columbia Public School Employers' Association. In December 2013, the current Board determined that the Trustee Representative as well as an alternate be chosen in the same format as that used for the BCSTA Trustee Representative and alternate. During the restructuring of BCPSEA, the role of the BCPSEA representative will be as a liaison for each Board of Education to BCSTA as outlined in the interim bargaining structure. Given this change in role, the Board may wish to review the requirement for a separate BCPSEA representative until such time as a new structure has been implemented.

Procedurally, the Board may elect its representatives as follows for each of the following four positions:

- > British Columbia School Trustees Association Provincial Council representative and alternate
- British Columbia Public School Employers' Association representative and alternate

#### Procedure:

- 1. the Chair will call for nominations for the Board's representative to each of the respective organizations for the term of January 18, 2017 December 30, 2017 (no second required).
- 2. declare the representative elected if there is only one nomination.
- 3. if there is more than one nomination, appoint two scrutineers and conduct an election by ballot.
- 4. the Chair will announce the successful candidate.
- 5. repeat steps 1 to 4 for the Board's alternate representative to the organization.

#### 414 Prohibiting Access to Schools

Adopted: December 6, 2016

Proposed Revised: January 17, 2017

# proposed Revised

#### **Policy**

The safety and security of students and staff is a high priority for the North Vancouver School District. Section 177 of the *School Act* is intended to prevent the disruption of schools and school functions, and to ensure the protection of students and staff. This section allows the Principal, Vice Principal, Director of Instruction or a person authorized by the board, to direct a person to leave school property. Section 177 may be used to prevent a stranger who presents a threat to student safety from accessing school property. There may also be circumstances where persons associated with the school, such as students, parents, employees, or volunteers are denied access to school property under Section 177. It also enables the administrator to call for assistance from law enforcement if necessary.

Persons directed to leave school property under Section 177 of the Act may not return without the prior approval of the Principal or designate. If a person contravenes this section of the School Act, he or she commits an offence.

A Section 177 direction can be appealed. The appeal process is delineated in the Administrative Procedures for this policy and will be provided to any person directed under Section 177.

Section 177 of the School Act is intended to be used only in exceptional circumstances, where there is a risk to student/staff safety or significant and ongoing disruption to the educational programs offered by the school.

The full text of Section 177 of the School Act is provided below:

#### Maintenance of order

**177** (1) A person must not disturb or interrupt the proceedings of a school or an official school function.

- (2) A person who is directed to leave the land or premises of a school by a Principal, Vice Principal, director of instruction or a person authorized by the board to make that direction
  - (a) must immediately leave the land and premises, and
  - (b) must not enter on the land and premises again except with prior approval from the Principal, Vice Principal, director of instruction or a person who is authorized by the board to give that approval.
- (3) A person who contravenes subsection (1) or (2) commits an offence.
- (4) A Principal, Vice Principal, or director of instruction of a school or a person authorized by the board may, in order to restore order on school premises, require adequate assistance from a peace officer."

Section 1 of the School Act defines "school" as follows:

#### "school" means

- (a) a body of students that is organized as a unit for educational purposes under the supervision of a Principal, Vice Principal or director of instruction,
- (b) the teachers and other staff members associated with the unit, and
- (c) the facilities associated with the unit, and includes a Provincial resource program and a distributed learning school operated by a board."

### DRAFT POLICY 414: PROHIBITING ACCESS TO SCHOOLS ADMINISTRATIVE PROCEDURES

- 1. Prohibiting a person from a school should only occur after other reasonable options to resolve the situation have been considered and/or attempted and only under the following circumstances:
  - there is a risk to the safety of students, staff, or others in the school community
  - the person poses a significant and ongoing disruption to the educational programs offered by the school, or
  - when directed to do so by a peace officer
- 2. Where practicable, consultation with the Director of Instruction or with the Assistant Superintendent should occur prior to issuing an exclusion order under section 177. In the case of an ongoing disruption, consultation with the Director of Instruction will be required.
- 3. The administrator issuing an exclusion order should call for assistance from the RCMP in the event the individual poses an imminent threat or refuses to leave after being directed to do so.
- 4. All exclusion orders must be documented and reported to the Superintendent, the Safe and Caring Schools Coordinator, and to the RCMP within 72 hours of issuing the order. A record of the order, and all related processes, will be kept at the school, in the Superintendent's office, and in the office of the Safe and Caring Schools Coordinator, until the order expires, in a manner consistent with the Freedom of Information and Protection of Privacy Act.
- 5. Principals will inform school staff, on a need to know basis, of who has been excluded from the school property. Employees are expected to maintain confidentiality in accordance with <a href="Policy 506: Employee Code of Conduct">Policy 611: Privacy</a>.
- 6. Written notification will be delivered to the excluded person within five business days, using the NVSD Section 177 template, including reasons for and the length of the exclusion, date for review, and information about avenues of appeal.
- 7. The excluded person may appeal the exclusion to the immediate supervisor of the administrator who issued the order. This may be the Director of Instruction, the Assistant Superintendent or the Superintendent. The appeal must be filed in writing within thirty working days of the date that the order was received by the excluded person. The appeal must be reviewed in a meeting with the excluded person and a written decision rendered within ten working days of receipt of the appeal. Should the decision to exclude significantly affect the education, health or safety of a student, an individual may file an appeal under Section 11 of the School Act and North Vancouver School District Policy 906: School Act Appeals.

Travel to Australia and New Zealand will be by air, and rental vans will provide transport during the stay. Accommodation will be in hostels. The per-student cost of approximately \$3,440 will be paid by the students.

The purpose of this extracurricular trip is athletic participation in a variety of individual rugby matches, as well as participation in a scheduled High School 7's tournament. Students will also have the opportunity to visit local tourist and cultural sites during their stay.
