A. Call to Order

Board Chair George Tsiakos called the meeting to order at 6:30 p.m. and acknowledged the traditional territorial lands of the Squamish Nation and Tsleil-Waututh Nation.

Motion to Approve Trustees Participation by Microsoft Teams

Chair Tsiakos provided an update on COVID-19 including the vaccination program for K-12 educational staff and reminded everyone to continue to follow restrictions. Information surrounding the School Trustee By-election was provided noting that five candidates have put their names forward. Chair Tsiakos acknowledged World Autism Awareness Day, Earth Day and the designated Day of Mourning for those who have lost their lives to work related incidents which all are occurring in the month of April.

Mandy Young (on behalf of multiple families), Michelle Sawyer and Tiffany Paul, all residents of North Vancouver, provided written submission in support of creating an Intellectual Disabilities Advisory Committee.

As per the motion passed on May 26, 2020, the Board of Education provided a twenty minute stakeholder comment period to allow stakeholders to speak to items on the Board of Education Agenda.

A.4. Stakeholder Comment Period (continued)

Jennifer Branston, Co-Chair of North Vancouver Parent Advisory Council, spoke regarding the proposed Intellectual Disability Advisory Committee. Ms. Branston shared that the committee would be a great benefit to the School District by providing meaningful supports and services to students.

Katrina Russell, First Vice President of North Vancouver Teachers' Association (NVTA), commented on the vaccination program noting that teachers are happy to have access to vaccines. Ms. Russell shared that the NVTA would like to see more consultation and collaboration for new school buildings and asked that privacy screens be added to shared working spaces in Argyle Secondary School. Additionally, there is a continued uncertainty surrounding school in September and the NVTA would like to see the Board prioritize funding to staffing and resources.

Brenda Bell, District Principal of Human Resources and Liaison for the District Student Leadership Council (DSLC), read a message from grade 12 student, Hannah Cook. Ms. Bell shared Hannah's reflections on the most recent DSLC Forum. The Forum provides a space for students to participate in relevant topics and this year the topic was *Empowering Students Towards a Sustainable Future*. The message from Hannah ended with her hope that the DSLC will continue to grow and she took the opportunity to wish all graduates good luck in the future.

B.1. Child Care Opportunities Identified During the North Vancouver School District's 2020 Site Analysis

Assistant Superintendent Chris Atkinson introduced this agenda item, inviting Facilities & Planning Coordinator James Bell to present an analysis of child care opportunities to the Board of Education. Mr. Bell presented an analysis on the:

- · important considerations for creating childcare facilities;
- constraints that the NVSD faces in implementing childcare programs;
- a review of where existing childcare facilities within the district are successful; and,
- an analysis of properties to identify where future childcare programs could be successful.

Responding to Trustees' questions, Assistant Superintendent Atkinson clarified why the sites had been identified and timelines for the implementation of these proposed child care sites.

Trustee Higgins reported on the meeting that showcased budget development for 2021/22, including presentations on the Forecast to June 30, 2021, the Preliminary Operating Grant for next fiscal year and Three-Year Forecast. Memorandum): 2021/22 Budget Consultation Update and Board Direction

Narration:

At the November 17, 2020 Public Meeting, the Board of Education approved the budget process for the 2021/22 Preliminary Annual Budget. The five partner groups; North Vancouver Parent Advisory Council (NVPAC), North Vancouver Teachers' Association (NVTA), Canadian Union of Public Employees (CUPE Local 389), North Vancouver Administrators (NoVA), and District Student Leadership Council (DSLC) were invited to attend information sessions and participate in discussions about the 2021/22 Budget Priorities at the scheduled Finance and Facilities Standing Committee Meetings. The Board requested that the 2021/22 budget priorities be framed in the context of the draft 2021-2031 Strategic Plan.

At the February 2, 2021, Finance and Facilities Standing Committee meeting, attendees were provided with the key components for the 2021/22 budget development including historical and current revenues and expenses, budget timelines, operating grant and the three-year forecast. Participants and interested individuals were asked to provide their suggestions for the 2021/22 budget priorities by emailing or using the *Thoughtexchange* online platform.

On March 12, 2021, the Ministry of Education announced the 2021/22 Preliminary Operating Grant for next year. The preliminary operating grant is based on the three year enrolment forecast submitted by the District in February 2021. For 2021/22, the Labour Settlement Funding was rolled into the Per Pupil Funding rather than being provided as a separate allocation as done in previous years. As a result, although the Per Pupil Funding have increased by 4.3% over the previous year, the change is largely attributed to combining the two allocations. The preliminary operating grant also provides for the Classroom Enhancement Fund (CEF) at 90% of the required teacher staffing and a fixed allocation of overhead funding.

Following the September 1701 enrolment submission to the Ministry, typically the Ministry will revise the operating grant based on actual enrolments, the remaining eligible CEF and other formula driven changes. The District's preliminary operating budget is developed based on the preliminary operating grant as announced by the Ministry, leaving any budget shortfall to be funded through an appropriation from the District's accumulated operating surplus.

The focus of the April 6, 2021 Finance and Facilities Standing Committee Meeting was presentations related to 2021/22 budget priorities. Updates were provided on the current year forecast to June 30, 2021, the Preliminary Operating Grant for next fiscal year and Three-Year Forecast. Partner groups presented their budget priorities. Attendees were asked to discuss and provide further input on the budget priorities for the 2021/22 through small and large group discussions.



At the May 4, 2021 Finance and Facilities Standing Committee meeting, staff presented an analysis of the revenue planning assumptions and projections for next year. The presentation reviewed the significant revenue sources from the Ministry of Education grants and District generated revenues. Based on planning assumptions, District generated revenues are expected to be approximately \$5.0 million lower in 2021/22 than 2019/20, pre-COVID-19 levels.

Based on the April submissions from partner groups and community members, the Executive Committee has organized this input and offered recommendations and will provide an update on the 2021/22 budget development.

Narration:

In 2019, the North Vancouver School District began a consultative process to create its next 10-year Strategic Plan. The 2021-2031 Strategic Plan will support the over-arching Vision of the North Vancouver School District and its priorities in pursuing the highest level of service we can provide to students and the community.

To gain valuable insight and feedback from students, staff, parents and stakeholders, the North Vancouver Board of Education hosted in-person, facilitated consultation sessions as well as online engagement through *Thoughtexchange* between November 2019 and February 2021. Strategic Planning sessions were held with the District Student Leadership Council, Canadian Union of Public Employees – Local 389, North Vancouver Administrators, North Vancouver Teachers' Association, Squamish Nation and Tsleil-Waututh Nation. Below is a listing of the engagement opportunities:

Date	Engagement opportunity
November 13, 2019	In-person, facilitated consultation. This large, three-hour strategic planning session will bring roughly 360 people together from all schools in the North Vancouver School District. <i>Participants have already been selected for this session.</i>
November 27, 2019	The North Vancouver Parent Advisory Council will host a one-hour, facilitated strategic planning session. All parents are invited to attend. 7 p.m. at the Education Services Centre (2121 Lonsdale Ave, 5 th floor).
December 4, 2019	The District Student Leadership Council will host a one-hour, facilitated strategic planning session for the entire District Student Leadership Council.
January 9 to February 7, 2020	The entire community is invited to provide input, and engage with input provided by others, through the online engagement tool Thoughtexchange.
January 18, 2020	The entire community is invited to a public open house to provide their input and to engage with the input already provided by others. 10 a.m. – 2 p.m. Drop-in format. Education Services Centre (2121 Lonsdale Ave, 5 th floor).
March 3, 2020	In-person, facilitated consultation. This large, four-hour strategic planning session will bring back together the 360 people who attended the November 13, 2019 event. This session will focus on reviewing the feedback provided to date, grouping the feedback into key themes and identifying where there is shared understanding.



January 26 to February 12, 2021	The online engagement tool <u>Thoughtexchange</u> will be used to present back to the community the draft goals that will shape the 2021-2031 strategic plan. The community will be asked to reflect on if anything needs to be adjusted, added or considered further.
Feb- April 2021	The North Vancouver School District will report back to the community on the 2021-31 Draft Strategic Plan.
April 2021	Board of Education and Staff commence draft Two-Year Operational Plan design.
May 2021	Final Strategic Plan presented to the Board of Education at Public Board Meeting.
June 2021	Two-Year Operational Plan presented to the Board of Education at Public Board meeting for information.
June to September 2021	The new strategic plan will be presented to the community.

The new strategic goals outline the priorities and direction of the North Vancouver School District for the next ten years and form the basis for the 10-Year Strategic Plan. The new goals are:

- Student-Centred Education: Provide equity-based education that supports the learning needs of all students.
- **Innovative Instruction:** Enhance innovative and effective approaches and curriculum to develop educated citizens.
- **Welcoming and Inclusive Culture:** Enhance our welcoming, safe, and inclusive culture and learning environment.
- **Mental Health and Well-being:** Promote mental health and well-being through social-emotional learning and trauma-informed practices.
- Truth, Healing, and Reconciliation: Champion truth, healing, and reconciliation, and embed Indigenous ways of knowing.
- **Environmental Stewardship:** Lead on sustainable practices and nature-based learning to address environmental challenges.




Executive Summary



Measuring Success



Narration:

The North Vancouver School District, with the support of the Ministry of Education, has had the privilege in recent years of designing and developing two new secondary schools – Argyle Secondary School and, now, Handsworth Secondary School. The design for both of these new build projects is the result of extensive consultation and the nexus of educational and architectural thinking. Assistant Superintendent Dr. Pius Ryan, Argyle School Principal Kim Jonat, District Principal of Inclusive Education Melanie Learoyd, and District Vice-Principal Janis Mann will present an overview of the design process followed for our secondary school buildings, the factors considered to provide facilities to support student learning, and the current use of learning spaces in our schools.

The presentation includes a review of the NVSD Design Principles developed as result of focus groups with representative secondary school teachers, the Design Committee and design consultation structure, as well as the key architectural concepts used in the design. In addition, the presenters will provide an overview of the current use of space, with a focus on a specific learning community through the lens of Inclusive Education.

Memorandum): Elementary School Fees 2021/22

Narration:

In accordance with the *School Act* s. 82 (3), Boards of Education may charge supplementary fees to students and parents for goods and services provided by the board. The North Vancouver School District Board of Education has developed Policy 706: School Fees, incorporating the requirements and provisions of the legislation and detailing administrative procedures for establishing and communicating school fees. The policy is reviewed on an ongoing basis to ensure consistency with changes in legislation, to reduce ambiguity in interpretation, and to support appropriate implementation.

Policy 706 requires that each North Vancouver elementary school annually establish a schedule of fees. Elementary school fees are developed and reviewed each spring, in order that they may be published to school communities in advance of the school year in which they will apply.

The process for developing school fees requires school administrators to consult with appropriate staff, students, and parents (PAC), and to establish supplementary fees at the minimum level necessary to recover the cost of the activity/material. The Superintendent of Schools annually reviews the individual schedules of school fees for consistency across the school district.

Each spring, the schedule of fees for the following year is provided to Trustees for their information. Accordingly, the *Schedule of Supplementary Elementary School Fees 2021/22* for the North Vancouver School District is attached for the Board's information.

Policy 706: School Fees requires the Superintendent of Schools to review annually the schedule of school fees for all schools and to provide this schedule to Trustees for their information. Listed below is an overview of the Supplementary Elementary School Fees established for the 2021/22 school year.

A. ELEMENTARY SCHOOLS SUPPLEMENTARY FEES

Supplementary Elementary School Fees have been developed at each individual school through a consultative process that involves the school principal, staff, and parents of the school community, and includes a presentation of proposed fees at a Parent Advisory Council (PAC) meeting. The following identifies the fee categories and, where supplementary fess are charged, the range of fee amounts that have been established at elementary schools across the school district for the 2021/22 school year.

[&]quot;School Supplies" Some elementary schools offer or facilitate the purchase of a "School Supplies" package. This is offered to families as an optional, convenience service, on a cost-recovery basis. Where this occurs, families may alternately choose to purchase school supplies on their own and a supplies list will be provided.

Each NVSD school will post their supplementary school fees for 2021/22 on their individual school website or will publish the fees in their school newsletter. Fees are charged **only** for materials or activities that are supplemental to what is required to sufficiently meet the Province's general requirements for graduation.

Meeting Summary of the Board of Education's Education and Programs Standing Committee meeting held virtually on Microsoft Teams on Tuesday, May 4, 2021.

Call to Order:

Standing Committee Chair Kulvir Mann called the Finance and Facilities Standing Committee meeting to order at 7:00 p.m., thanking those in attendance for participating with the School District. It was noted that this virtual meeting was being recorded and would be posted to the School District website following the meeting. The traditional territorial lands of the Squamish Nation and Tsleil-Waututh Nation were acknowledged.

Committee Chair Mann shared that all attendees are encouraged to ask questions and provide comments throughout the Standing Committee Meeting by using the raise hand function and chat function in Microsoft Teams.

Revenue Analysis – 2021/22 Operating Budget Development:

Secretary Treasurer Jacqui Stewart introduced the presentation, inviting Director of Financial Services Kristen Watson to provide context on the planning assumptions and forecasted enrolments for revenues in the 2021/22 budget development. Ms. Watson highlighted the major sources of revenues which provides the foundation for next year's budget.

Ms. Watson reviewed the Operating Fund by breaking down the general revenues which include salaries, supplies, facilities, technology and professional development, and program revenues which typically run at a cost recovery. The significant sources for general revenue are operating grant, international tuition, rental and lease income, and interest income. Program revenues include Cheakamus Centre and Academies and Band and Strings. These make up 98% of the Operating Fund Revenue in 2021/22.

Concluding the meeting, Superintendent Mark Pearmain, Secretary Treasurer Stewart and Ms. Watson responded to Trustees' questions.
