#### Subject: Preparing for September

This letter is a follow-up to my message of August 25th to update you on the current labour dispute and provide information about the potential for schools to open, or not, on Tuesday, September 2nd.

### The possibility of mediation

Representatives of the British Columbia Public School Employers' Association (BCPSEA) and the British Columbia Teachers' Federation (BCTF) met yesterday, and are meeting again today, with mediator Vince Ready. The intention of these talks is to assess the readiness of both parties for mediation. Depending on developments over the weekend, there is a possibility that school may open on Tuesday for our standard shortened opening day.

### When will parents know if schools will open?

Please visit <u>www.sd44.ca</u> on Monday evening for an announcement to confirm whether or not school will be open on Tuesday, September 2<sup>nd</sup>.

We realize and respect that teachers have not been at work for a long time and that schools are not fully prepared for our regular opening procedures. However, as soon as this year's opening date is confirmed, we will welcome staff and students back, go through our first day, and begin the work of the year ahead. Teachers and support staff are experienced and skilled in addressing the demands of this time of year, and principals and vice-principals have well-developed routines in place. Attached please find Frequently Asked Questions (FAQ) for further information on this year's start-up procedures.

#### Keeping informed

I will write again next week and school principals are also in the process of sending important information and direction for the start of the school year. Whether or not our start date is delayed, please take the time to read these messages in order to assist us with our opening procedures and the smoothest start possible for students under the circumstances.

#### Q: Is it still possible that schools will open on September 2<sup>nd</sup>?

**A:** Yes. If an agreement is reached for a negotiated settlement, or a lifting of strike/lockout action while mediation is underway, then we will be ready to open schools on September 2<sup>nd</sup>.
