INFORMATION ABOUT THE NORTH SHORE YOUTH ACADEMY:

Attention West Vancouver, North Vancouver School District students, and North Shore Private School students in grades 10-12! We are excited to announce our upcoming North Shore Youth Police Academy designed specifically for individuals interested in operational or front-line policing. If you are passionate about pursuing a career in law enforcement, this is a fantastic opportunity for you.

During the academy, which spans over 4 days, participants will have the chance to experience various aspects of policing. This includes engaging in police physical training such as running, hiking, and weightlifting, as well as learning about K9 services, traffic services, community policing, forensics, and other specialty units.

The primary goal of this program is to empower youth by fostering teamwork, mental resiliency, leadership skills, mentorship, and providing a foundation in basic law enforcement skills. These skills will not only benefit participants in their potential future careers but also in their everyday lives.

If you are dedicated, physically fit, and eager to excel in a demanding role, we encourage you to apply for this exciting opportunity. Don't miss out on this chance to gain valuable experience and insights into the world of policing.

APPLICANT REQUIREMENTS

To be considered as an applicant, you MUST meet the following minimum requirements:

- 1) Age: You must be between the ages of 14-17 years at the time of application.
- 2) Grade Level: You should be in Grades 10, 11, or 12 by the September 2024 school year.
- 3) School Attendance: You must attend a school within the West Vancouver or North Vancouver School District, or be a student at a North Shore Independent School.
- 4) Criminal Record: It is essential that you have no criminal record or have been arrested in relation to any serious or violent offences.
- 5) Physical Fitness: You should be capable of participating in physical fitness classes that may include activities such as running, hiking, and weightlifting.
- 6) Learning Orientation: You should have a genuine desire to learn skills, methods, and tools that will contribute to your future success.
- 7) Community Engagement: You should be motivated to make a positive impact in your community.
- 8) Team Participation: It is important that you are willing to actively engage and participate in team activities, while also having fun and working hard.





By meeting these requirements, you will increase your chances of being considered for the Youth Academy.

In the event that the number of applicants exceeds the available space in the program, priority will be given to Grade 12 students. This means that if there are limited spots, those who are in Grade 12 will be given preference during the selection process.

A waitlist will be started, and students will be notified should a space become available at a later date.

YOUTH ACADEMY DETAILS:

Please be advised that the Youth Academy is a collaborative initiative between the West Vancouver Police Department and The North Vancouver RCMP. Upon successful selection, candidates will have the opportunity to attend either the Academy hosted by the West Vancouver Police Department or the one hosted by the North Vancouver RCMP. Applicants may specify which program dates they prefer; however, the final assignment of candidates will be determined based on various factors and will be communicated accordingly.

YOUTH ACADEMY OVERVIEW:

Participating students will:

- Engage in simulated Police training environment that involves role-playing the realities of policing in a condensed format;
- Receive instruction and lectures on law, social and communication skills, physical training, as well as <u>some</u> police tactics and other topics;
- Simulate the role of a police officer and observed role-playing, sharing their observations;
- Speak in front of groups while being evaluated by the instructional staff and their peers; and
- Be required to work in a team and partake in all the planned activities.

ACKNOWLEDGMENT OF RISK, WAIVER, RELEASE & INDEMNITY

TO BE READ AND SIGNED BY PARENT OR LEGAL GUARDIAN ONLY

Definitions:

- In this document "WVPD" refers collectively to the District of West Vancouver, West Vancouver Police Department and its officials, officers, employees, trainers and representatives (collectively, "the WVPD").
- In this document "NV RCMP" refers collectively to the North Vancouver RCMP and its officials, officers, employees, trainers, and representatives (collectively, the "NV RCMP")

I am aware that my signing this document is a condition of my Child being eligible to participate in the North Shore Youth Police Academy ("The Program") which participation may be cancelled by the WVPD and/or the NV RCMP at any time without prior notice or hearing.

I am aware that my Child's participation in The Program will not entitle them to any payment nor salary, or other compensation or prizes of any kind to be provided by the WVPD or the NV RCMP for my Child's participation as a volunteer.

I am also aware that as a participant, my Child is not an employee of the WVPD or the NV RCMP and am not entitled to Workers Compensation Board benefits and my Child is not entitled to any medical, disability or other insurance benefits or coverage of any kind.





I am also aware that my Child's participation in The Program does require a certain level of physical health and ability and that I accept and bear full responsibility for my Child's physical health and ability to participate in The Program and that the WVPD and the NV RCMP have advised me to consult my Child's family physician prior to participating in The Program.

NOTICE TO PARENT OR LEGAL GUARDIAN

I acknowledge that it is a condition of my Child's participation in the Program that I, the undersigned Parent/ Legal Guardian of the Child, must carefully read and understand this document and sign it to acknowledge that I have read and understand it and that I understand that my Child's participation in the Program will expose the Child to risks of harm and that I accept full responsibility for exposing my Child to such risks.

PARENT/ LEGAL GUARDIAN RESPONSIBILITY FOR CHILD

I, THE UNDERSIGNED PARENT/ LEGAL GUARDIAN, AM THE PARENT AND/OR LEGAL GUARDIAN OF MY CHILD AND FOR MY CHILD I HEREBY CONSENT TO THEM PARTICIPATING IN THE PROGRAM, AND, FOR MYSELF AND THE CHILD, IN RETURN FOR THE WVPD GROUP AND THE NV RCMP ALLOWING THE CHILD TO PARTICIPATE IN THE PROGRAM:

This document will be exclusively governed by and interpreted in accordance with the laws of British Columbia and no court outside of British Columbia will have any jurisdiction over this Consent, the Program, or any of the matters arising from them.
