



TAKE OUR KIDS TO WORK DAY

Wednesday, November 1st, 2023

To all students in Grade 9 and their parents/guardians,

This year Wednesday November 1st is designated as our district *Take Our Kids to Work Day* for all Grade 9's. Once a national program started in 1994 by the Learning Partnership, this day has been considered the most recognized career exploration event in Canada with more than 250,000 Grade 9 students and about 75,000 businesses and organizations nationwide participating. The initiative continues in our district and offers value in that it engages students to think about careers and the concept of networking, better understand the work world, and to appreciate parents' careers and their roles in supporting their families.

We encourage all parents to provide a meaningful and safe work placement for their child and/or encourage students to explore possible networks who can support a job shadow experience. To be clear, **this is NOT** a Seycove school field trip as no staff will be involved in organizing, supervising, nor attending any of the workplaces. Parents are responsible for all aspects of their child's work placement/shadow including transportation and safety for this initiative.

The day is most successful when students and their parents find a good work site or person to shadow either through relatives or through family friends. The timing and details of the day are completely up to the parent and the work site/shadowed employee. Teachers of Grade 9 students will expect many to be away and will not plan for any tests or work during class time.

The school's role is to be flexible with the day and plan for the students who are unavailable to find a placement or do not wish to take part. If your student does not have a placement, or have arranged for a different day, they are required to be at school. **All students without a placement will meet in the Library at 9:15am.** Activities planned for the duration of the day will depend on the number of students in attendance, and will include an alternate Careers activity to watch, discuss, and reflect on their viewing of a few well-crafted videos that depict a wide variety of career fields.

Please have your Grade 9 return the consent form to the school's main office by October 27th, 2023 so that the school can plan for the day and mark the correct attendance. *If you lose this form*, please visit Seycove's homepage for a copy to print off.

- Exploring career options in a practical way and gain a better understanding of what is open to them
- By spending a day in the life of a working adult, they develop an appreciation and deeper understanding of their parents'/ adult work and motivation

- Discussing work experience with their child
- Beginning a career discussion based on actual experiences
- Enriching their child's experience with discussion before, during and after the workplace visit.
